Changes based on the Strategic Planning Meeting

An **Advisory Committee** will be created that includes the Advisor, each of the team leaders, and any other content specialist determined by the BOD. The Advisory Committee will meet quarterly and be led by the First Vice-Chair which serves in the role of Advisory Committee Chair. The Advisory Committee members are content experts and will be utilized to help guide the BOD.

The ArCOP Teams will include:

- 2. Growing Healthy Foods (GHF)
- 3. Growing Healthy Places (GHP)
- 4. Growing Healthy Kids (GHK)

The goal of the teams is to disseminate relative information and educate on success stories. Each team will be asked to hold a monthly meeting on a set day and time of each month. The teams are asked to organize 30 minute meetings that will host a speaker to provide a 15 minute educational presentation, 5 minute Q&A and 10 minutes of resource sharing and updates.
